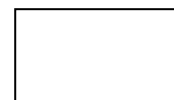

5.1 Ward Councillor

Swimming Pool will not be closing or Sports facilities in Ross but are currently underused.

Children's centre to stay open but will have to diversify the use of the building.

CPO (Compulsory Purchase Order) signage for new link road to be posted in Hereford

Many telephone calls regarding surface water on Welsh Newton Common
Nationwide purge for Fostering and Adoption, Herefordshire has a very good record for fostering

Grass verge cutting has to take a lower priority to assist in maintaining other essential services

5.2 Village Hall Committee Delegate

Nothing to report as no meeting held

5.3 Llangrove School Delegate

Janet Taylor Llangrove Primary School Chairperson reported that it is very difficult for smaller schools (less than 100 pupils) to remain viable

In January 2011 Herefordshire merged some of the schools in particular Scudamore School, Sutton School, Kings Caple School and Canon Pyon School

Problems arose in this grouping because of multi religions

There are now two head teachers at Scudamore School with an assistant head managing Llangrove School

The schools are very much improved with "ambassador teaching" for younger pupils

Staff and assistants are now better trained and funded

There are 34 pupils currently in Llangrove School but in September children moving up from "Leap Frogs" will boost numbers to 40.

Llangrove School could not have survived without these measures

6.0 Jubilee Textile Hanging

Due to restrictions and conditions the finished “Jubilee Wall Hanging” is not suitable for public display in the Church.

9.0 Annual Report Publication

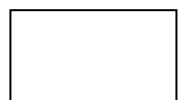
